There will be plenty of work to do. I will help, and I hope you will too.

ECONOMIC IMPACT OF JEFFCO

Ken McMillen told members that economic development is one of the jobs of the Port Commission.

So, just what does our airport contribute to the community in dollars and cents?

Well, the State of Washington hired a consultant to measure the economic impact of all the public airports in the state. The report shows that Jeffco is one of the more robust in the state - ranking sixth in economic power among the 19 public airports in the Olympic Region - which stretches from Pierce Co. to Clallum Co.

Specifically, our airport contributes 153 jobs, \$2.7 million in annual payroll and almost \$10 million in total economic activity to Jefferson County.
